MINUTES The Minute of the meetings of the meeting of February 7th, having been circulated, was approved.

ROLL OF PRESBYTERY

The Clerk reported

- i. that a request had been received from Revd Irene Bristow to transfer her membership from the Presbytery of Dunfermline to the Presbytery of Ardrossan, and that he had received a presbyterial certificate for Mrs Bristow from the Presbytery of Dunfermline. The Moderator addressed to Mrs Bristow the question appointed in terms of Act III 1992 (13). Mrs Bristow, having answered in the affirmative, signed the formula and her name was added to the roll of Presbyte
- ii. that Mr and Mrs Peter Hinde, and Mr James Forsyth, additional elders, had indicated that they wished to resign their seats in Presbytery, with effect from June of this year.
- iii. that Mr Colin Mills had written to the Council of Ministries, tendering his resignation as a Reader. Mr Mills' resignation was noted, and the Clerk was instructed to write to him, thanking him for his services to the Presbytery

- ii. Concur with the decision of the congregation of Kilbirnie: Auld Kirk, as contained in an extract minute of a Congregational Meeting held on 19th February 2006, to adopt the Unitary Constitution.
- iii. Note the decision of the Vacancy Procedures Committee in the case of Saltcoats: New Trinity to sustain a call to the Revd Eliane Mackinnon and to appoint Thursday April 6th at 7.30pm for Miss Mackinnon's induction, the Presbytery to meet at 7.15; Revd Alison Davidge to conduct the devotions and the Revd Martin Thomson to preach and give the charges.

- v. Note that at extract minute had been received from the General Assembly's Parish Appraisal Committee stating that it had been reported to the Parish Appraisal Committee "that the Ministries Council, at a recent meeting, had agreed that its funding priority is the sum total of agreed posts in Presbytery Plans, and it was agreed to communicate this decision to the Presbytery", and remit to the Business Committee to bring to the next Presbytery meeting an indication of outline arrangements for completion of the Presbytery Plan.
- vi. Note that an extract minute had been received from the General Assembly's Parish Appraisal Committee clarifying its decision on the Basis of Linkage of Brodick, Corrie, Shiskine and Lochranza & Pirnmill: "The minister of the linked congregations shall have the part-time assistance of an ordained minister as agreed by the Ministries Council, and such other assistance as shall be agreed by the minister, when inducted, the Presbytery and the Ministries Council, provided by the Ministries Council", and concur.
