The Presbytery retired to the hall where the Clerk Pro tem was instructed to add Mrs Whitecross's name to the Roll of Presbytery, to send certified intimation of the Induction to the Kirk Session of Kilwinning: Old Parish Church and to the Council of Ministries and the Presbytery of Dumbarton.

The officiating Ministers were thanked by Mr R Lavalette. The Revd Dr Johnson McKay was thanked, in his absence, for his services as Interim Moderator and Locum and discharged from these duties.
